ORDINANCE TO REGULATE PARKING ON MAIN STREET

The Village of Beaverdam, Ohio, met in regular session on the 5th day of February, 2019, to consider adoption of the following:

WHEREAS, the Village Council recognizes the need to provide safe conditions for those traveling on public streets within the Village; and

WHEREAS, parking on Main Street needs to be regulated for the public's peace, health, and safety.

NOW THEREFORE, BE IT ORDAINED, by the Council of the Village of Beaverdam, a majority therein concurring that:

1. No persons shall stop, stand, or park a motor vehicle, as described in the Ohio Revised Code, on either side of Main Street, except in conformance herewith;
2. There shall be no parking at any time on the South side of Main Street.
3. There shall be no parking on the North side of Main Street, except in designated areas and at designated times.
4. This Ordinance shall not apply to emergency motor vehicles, vehicles of a public utility when stopped or parking is necessary in order to effectuate repairs and/or maintenance on any public utility;
5. It shall also be an exception to this Ordinance, if stopping is necessary to avoid a conflict with other traffic, or in compliance with the directions of a police officer, state law, or traffic sign or device;
6. The Village Administrator shall cause appropriate signage to be erected, or to be painted on, or near, the parking spaces, to give appropriate notice of these regulations;
7. A violation of this Ordinance shall be a minor misdemeanor for the first violation, and shall be a misdemeanor for each subsequent violation occurring within a six-month period of the prior violation;

The Fiscal Officer is hereby ordered to give notice of the adoption of this Ordinance, by publication within the five (5) locations in the Village, as previously established by Ordinance.


